Ref: PCDA Allahabad Letter No.A/II/3795/LXXVIII dated 01/07/2020.

The Revised Estimate for the year 2020-2021 and Budget Estimate for the year 2021 -2022 are due for submission to PCDA (Pension) Allahabad in respect of Civil Pension as well as Defence Pension.

2. In this connection, it is stated that the payment on account of "Encashment of Earned Leave" at the time of Retirement / Death / Termination of Service is being Classified to the Head "Pension and other retirement benefits - Leave Encashment" from the financial year 1999-2000, for which separate Code Heads have been introduced in respect of ARMY, NAVY, AIR FORCE, Defence Civilians, DAD, BRO, CGO & JAKLI.

3. Accordingly, the projection under this Head is made by this office on the basis of the requirement of funds furnished by Sub-Offices & local sections of Main Office under PCDA Bangalore, for a particular financial year. Past experiences in this regard shows that the requirement of funds has not been assessed correctly by the sections / sub-offices under PCDA Bangalore, resulting in Excess / Less Booking, with reference to the requirements projected by them, which is adversely commented by the HQrs Office / Higher Authorities.

4. It is therefore requested that the requirement of Funds on account of "Leave Encashment" may be assessed as accurately as possible for RE 2020-2021 and BE 2021-2022 separately and sent to this Office by FAX or SPEED POST latest by 14th July 2020 positively(Preferably e-mail).

5. The requirement of Fund under Pension Contribution Heads as per 'Annexure 5' may also be accessed accurately and sent to this Office for RE 2020-2021 and BE 2021-2022 separately.

6. The formats in which estimates are required to be submitted to this Office ('Annexure 1' to 'Annexure 5') may please be downloaded from PCDA Bangalore website.


