Sub : Preventive Measures to contain spread of Novel Coronavirus (COVID-19)

Consequent on surge in COVID-19 cases in Bangalore, Govt of Karnataka has imposed lockdown of Bangalore for the period from 14.07.2020(8 P.M.) to 22.07.2020(5 A.M.). The guidelines on lockdown are annexed herewith for information and compliance of all concerned.

2. It is pertinent to mention that as per Govt Of India, Dept Of Expenditure DO F. NO. 23(4)/E-Coord/2020/1 dated 24.03.2020, Govt expenditure system is categorised as essential service and this organisation is part of it. Further, as per para 3(a) & (b) of the guidelines for lockdown issued by Govt Of Karnataka vide their order No. RD 158 TNR 2020 dated 13.07.2020, Defence and Offices maintaining essential services are exempted from being closed. As per para 9(e) of the above guidelines, movement of personnel having valid ID Card issued by the organisation to the place of work and back for permitted activities are allowed. The officers/staff may be advised to carry copy of this circular and original ID card while attending the office so that the same can be produced to law enforcing agencies, if demanded.

3. In addition, a Guidelines on “ **What to do if you test positive for COVID-19 in Bengaluru**” is also enclosed herewith for information and guidance.

The above may be brought to the notice of all officers and staff.


ORDER

Whereas, the State Government vide Order No. RD 158 TNR 2020, dated 30.06.2020, issued Unlock 2 guidelines for the entire State which permits re-opening of more activities in a calibrated manner, in areas outside the Containment Zones, and to extend lockdown in Containment Zones upto 31.07.2020. These guidelines will continue to be enforced throughout the State with the additional restrictions imposed under this order in Bengaluru Area.

Whereas, there has been a surge in COVID 19 positive cases in Bengaluru area, particularly in the last two weeks.

Whereas, the Experts have examined the matter in detail and have suggested taking further stringent measures to contain the spread of COVID 19.

Hence, in exercise of the powers, conferred under Section 24 (1) of the Disaster Management Act, 2005, the undersigned, in the capacity of Chairman, State Executive Committee, hereby orders Lockdown of Bengaluru area comprising of BBMP area, Bengaluru Urban District and Bengaluru Rural District, to combat the spread of COVID 19, for a period of 7 days with effect from 8 pm on 14.07.2020 to 5 am on 22.07.2020. The guidelines on Lockdown are annexed for strict implementation by the Commissioner, BBMP, Commissioner of Police, Bengaluru, Deputy Commissioners of Bengaluru Urban and Bengaluru Rural districts, and Superintendent of Police of Bengaluru Rural District.
