Sub: Grant of Financial up-gradation under MACP Scheme for DAD Officers/Staff members – Reg.

The PCDA Bangalore hereby grant financial up gradation under the ACP/MACP scheme to the Group B/C Officers/staffmembers as mentioned in the Annexure "A" in the Pay Band and Grade Pay(6<sup>th</sup> CPC)/Pay Matrix Level(7<sup>th</sup> CPC) and with effect from the date shown against their names.

2. The financial upgradation is granted subject to the following conditions:-

- a) The Placement in the higher Pay Band & Grade Pay/Pay Matrix Level through upgradation under MACP scheme is only on personal basis and shall, therefore, neither amount to actual/functional promotion nor to change in the existing designation or seniority position.
- b) Financial benefits allowed shall be final and no pay fixation benefit would accrue at the time of regular promotion if it is in the same grade pay/Pay Matrix Level as granted under MACPS. However, at the time of actual promotion if it happens to be in a post carrying higher grade pay/Pay Matrix Level than what is available under MACPS, no pay fixation would be available and only difference of grade pay/pay in Pay Matrix would be made available.
- c) Grant of higher Grade pay/Pay Matrix Level under MACP scheme shall be conditional to the fact that if a regular promotion has been offered but was refused by the employee before becoming entitled to a financial upgradation, no financial upgradation shall be allowed as such an employee has not been stagnated due to lack of opportunities. If, however, financial upgradation has been allowed due to stagnation and the employee subsequently refuses the promotion, it shall not be a ground to withdraw the financial upgradation. He/She shall, however, not be eligible to be considered for further financial upgradation till he agrees to be considered for promotion again and the second/next financial upgradation shall also be deferred to the extent of period of debarment due to the refusal.


3. With regard to fixation of pay on grant of financial upgradation under MACP Scheme, option should be exercised within one month from the date of publication of this part II O.O. Pay fixation will be carried out as per the extant rules on the subject.
