**Sub:- Provisional Payment to avoid contempt proceedings.**

As per para-299 of Defence Accounts Code PCsDA/CsDA may use their personal discretion to authorize provisional payments in the absence of allotment under 'Charged Expenditure' in order to avoid 'contempt' of court. PCsDA/CsDA at the same time should show utmost promptitude in obtaining sanction for implementation of court judgment and release allotment of funds under charged expenditure, to the concerned authorities at Command HQrs.

3. In this context, Controller offices are requested that the details of such cases, where provisional payment has been made but not regularized may be furnished in the prescribed format as mentioned below:-
