Further, the exemption secured by the candidate in any of the paper(s) will not be carried forward in the revised pattern of examination held under SAS Rules 2019. As such it may be specifically clarified that no candidate should absent from the examination and it is in their interest to make full utilization of last special chance provided in the present syllabus. No representation in this regard will be entertained and forwarded to HQrs Office.**

3. Further, it is also intimated by HQrs that for the benefit of the candidates, the tentative schedule for holding next SAS Part II examination for 2019 would be as under. The final schedule and detailed instructions for conducting examination will be intimated separately in due course.
