Roll Numbers and centre of examination should be communicated to all the concerned individuals including those who are on leave/deputation/ attachment and his/her acknowledgement obtained and recorded at your end. Any corrections deemed necessary in regard to name/grade/account number/category/centre/section/Hindi option/exemption may please be intimated to this office by FAX or any other fastest mode of communication on or before **10.04.2018**. A NIL report may also be furnished.

3. The candidates who have been permitted to appear the above examination in the centre other than the nearest centre to their duty station at their own request/recommended by CGDA/PcsDA/CsDA **would not** be entitled for TA/DA. Further, the change of centre on any ground shall not be accepted.

4. As per Rule 6 a candidate who has qualified the Preliminary test but absents or withdraws his/her candidature from SAS Part I examination following immediately will be required to re-qualify in the Preliminary Test for eligibility to appear in SAS Part I Examination. Further, as per SAS Rule 14(b), each permission to appear in SAS Part I examination will count as one chance against the respective part, whether he/she actually sits for the examination or not unless he/she is specifically allowed to withdraw his/her name by the CGDA. In accordance with the ibid proviso read with SAS Rule 14 (d) withdrawal of the candidature not submitted within the laid down time period would count as a chance. It may be clarified that as per decision of MoD (Fin), withdrawal of a candidate on medical ground not submitted within laid down time period would also count as a chance. As such failure to appear in this examination by way of absenteeism or medical ground and request submitted after specified time limit in SAS Rule will entail forfeiture of one of the four valuable chances allowed to candidates as per revised SAS Rules. **Under no circumstances request for withdrawal in respect of candidates availing special chance will be accepted.** The candidates may be informed accordingly.

5. Further, in order to ensure transparency & fair conduct of examinations, it has been decided by the Competent Authority to Video graph the proceedings of the examination during all the four papers.

6. All the candidates taking the examination may be directed to bring their identity cards for verification on every day of the examination. The specimen signatures of the candidates duly attested by the SAO/AO (AN) may be obtained and forwarded to this office on or before **10-04-2018**.
